Board of Directors' Meeting #1 for 2009/2010 Minutes of Monday, October 19, 2009 Meeting Mansfield High School Library

Meeting was called to order at approximately 7:40 PM and it was determined that a quorum existed.

1. Treasurers Report(Shelley Rapoza)

- Shelley reported that she has not yet meet with Karen Savegeau and she and Walter have not received signing authority over the MGSA bank account. Walter has tried several times to contact with James Mahoney but has not received a reply. Tony advised that he would try to get in contact with James. The bank is requiring that Shelley, Walter, Karen and James all appear at the bank for the transfer of authority over the account.
- The board approved payment for the following bills:
\$150.00 to Grogan-Marciano for rubber balls
\$36.41 to Verizon
\$240.00 to Network Solutions for the new website domain
\$75.00 for purchase of website enhancement (paypal or google marketplace) to allow for online purchases of MGS apparel.
- \$350.00 for the purchase of the latest version of Quicken
- Gerard will speak to Mark Munroe regarding the admin password/contact to cancel eteamz website.

2. Website Migration Update(Bill Letendre)

- The new website (www.mansfieldgirlssoftball.com) is now up and running. The eteamz website only has a home page with the message that our website has been moved and the link to the new website.
- Registration for the Pitcher/Catcher Clinic is ongoing. An email blast was sent out to approximately 250 email addresses. To date, 24 girls have registered. A second email blast will be sent before the registration closing date of October 26. Walk in registrations will be excepted.
- The new website domain will allow the creation of @masnsfieldgirlssoftball.com email accounts. Each board member who was present agreed to have one setup for them that would then forward any email to a personal email account of their choice. The board also asked that a group email account be setup that would forward any emails sent to it to all members(this will be researched).
- Spring Registration: The board agreed that spring registration will open on November 1 and an email blast will be sent out to all members with registration

occurring online through the website like the pitching and catching clinic. The board decided that the following fees will be setup for spring registration:

\$75.00 for 8U and 6U.

\$95.00 for U14 and U12

\$10.00 discount per player will be applied to any player registering before January 1.

Any family with multiple players will have their registration fee capped at \$200.00 (will not include Swarm)

The registration period will close on February 14, 2010. People registering after February 14, 2010 will be accommodated based on availability.

The registration process will capture uniform shirt size (YS, YM, YL, AS, AM, AL, AXL), if they want to purchase a fundraising Mansfield softball t-shirt (\$12.00), if they would like to volunteer as a head coach, assistant coach, team parent, summer coordinator, division coordinator, volunteer, fundraising committee). It will also ask if they are interested in making a tax deductible donation to sponsor a Mansfield Girls Softball team. The board asked if the parent's email address can be required (this will be researched).

- Expansion of MGS Apparel offerings. The board was supplied with a list of apparel offerings that would be possible. The board members will review and make a decision at a later date. The board will also consider purchasing hooded sweatshirts for girls in their last year of MGSA (last year of 14U).
